He discussed the roof issues with Ms. Ballo and also the status of the F/T Youth Services Librarian position. 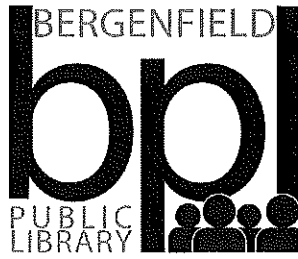
