Mayor Amatorio called the meeting to order at 8:02 p.m. with the reading of the Open Public Meetings Act Statement, "In compliance with the Open Public Meetings Act, the notice requirements have been satisfied. Meeting dates for the year are confirmed at the Annual Meeting. The Annual Notice is sent to the Record, Star Ledger, Twin Boro News, and Cablevision, placed on two Municipal Bulletin Boards and is on file in the Office of the Borough Clerk."

The Salute to the Flag was led by Councilperson Lodato.

APPROVAL OF MINUTES

VERBAL COMMUNICATIONS I

Mayor Amatorio opened the meeting and invited the public for comments on agenda items only, limited to five minutes per speaker.

Barry Doll, resident, stated he would like an explanation regarding Ordinance 24-2623. He stated that at the last meeting, there weren't any amounts listed for capital improvements and would like to know how it fits into the budget.

Borough Administrator Gallo stated the items included in the capital budget are road work, speed humps, vehicles, garbage trucks for DPW, and police vehicles. Mr. Gallo explained that \$1.5 million out of the \$4.2 million is monies that were part of the capital budget from last year and only \$2.7 million is being bonded. The \$1.5 million was CARES Act money that will be utilized towards the capital bond this year. Mr. Gallo stated the borough's budget collectively over the past five years, inclusive of this budget, will have an increase of 1.6%. They've done everything possible to be as efficient as possible. There needs to be an increase as medical insurance, salaries/wages, liability insurance, cost of goods and products have all increased.

Mayor Amatorio stated the budget for the Board of Education will increase by 2%.

There being no one else who wishes to be heard, Mayor Amatorio closed Verbal Communications I.

NEW BUSINESS

Mayor Amatorio stated that he would like to bring the following three items to the Council in hopes to receive updates on these matters.

A. Cooper's Pond Renovation and Pond Dredging

Borough Administrator Gallo stated that a \$750,000 grant was received from HUD and T&M Associates is currently scoping out the project and working on the application with DEP. It is a long, arduous process. He stated that dredging of the pond will be equally as challenging as other projects, there are no short cuts. He commented that in terms of the Cooper's Pond park improvements, including the walkway, lighting, gazebo, and building improvement, T&M started evaluating the projects and preparing their scope of work based on monies received and the million dollar grant. Mr. Gallo stated that at this time, the borough has received \$1.7 million for the dredging and renovations.

Mayor Amatorio stated that he understands the borough doesn't have the money, but he would like to start exploring and have a plan in place.

Mr. Gallo stated that the engineers have started working on this and he understands the walkways have to be done, the frontage entrance way and how this should be improved.

Mayor Amatorio stated the way Vivyen Park was done, the same should be done with Cooper's Pond. He would like to know the cost of renovating the entire park, including the building, to have a bird's eye view of the cost and see whether the borough needs \$2.5 to \$3 million to do the dredging, repair the walkway, and complete all the renovations.

Mr. Gallo stated that he will have a long-term plan available for everyone at the next meeting.

Councilperson Kornbluth inquired about the additional million dollars and how that should be spent.

Mr. Gallo stated that the borough has to work from the outside in, as the whole side of the pond may get destroyed from dredging. He stated that he looked at pictures from years ago and learned that the entire side the pond gets destroyed. Mr. Gallo stated they'll have to go in with heavy machinery, put everything into piles, and then they have to be tested and dried out. This will take a very long time.

Mayor Amatorio stated that we should speak to our team and put a plan in place.

Councilperson Pascual stated that we should have a plan and they should break it down in phases.

B. Phase II of Vivyen Field

Borough Administrator Gallo stated the borough received \$725,000 in federal grant monies to do the walkways around the park. He stated that he was required to attend a training in New Brunswick, and learned this will take about two years to complete.

Mayor Amatorio inquired what is the plan for fencing. He stated that he understands that it will go from the Dumont property to our property. He commented that Dumont should be notified to remove their equipment beforehand, so that they can prepare and find a place for their vehicles and equipment.

C. Park and Recreation Updates

Borough Administrator Gallo stated the borough is currently out to bid for the PAL lighting project. The borough received a \$955,000 Green Acres grant for this project. The borough also received a \$235,000 grant from DEP for the final phases for the rain garden at the PAL field, which is the area the trees were taken out. The borough will also be going out to bid for the surfaces of the updates of the basketball and tennis surfaces using the open space grant. The dug outs will be improved on Hickory Field. Mr. Gallo stated the borough is moving along with these projects, it just takes a long time because the borough needs to receive approvals in order to use the grant funds.

Committee/Department Reports

Motion offered by Council President Rivera that the Committee/Department Reports be spread upon the minutes in full and filed. Councilperson Deauna seconded the motion. All present voting in favor, none opposed.

VERBAL COMMUNICATIONS II

Mayor Amatorio opened the meeting to Verbal Communications II and invited the public to comment on any subject, limited to five minutes per speaker.

Borough Administrator Gallo stated that he received an answer to Mr. Doll's question. He clarified that the bond ordinance is \$4.2 million. Of that amount, \$1.7 million is debt, and \$1.5 million is cash on hand. There is zero increase to the budget. He explained that it is zero because the cash on hand is being used as the down payment for capital funding.

Chris Nowell, requested the governing body endorse a letter of support to Bergen County for a county wide complete streets policy. He stated he is aware Bergenfield has a complete streets policy, but it only applies to municipal roads. He commented the complete streets policy should

also include the county roads. He clarified that complete streets policies are not just about bike lanes, but about safety and accessibility for all roads uses, for children, the elderly, and the most vulnerable populations. Mr. Nowell stated that it has to do more with speed, as that is the most common factor that causes deaths and injuries. He stated that speed calming like speed humps, narrowing lanes, pedestrian bump outs are all approaches that can be taken. He stated that he searched online and Bergenfield has six county roads. He also received a list of road segments that are dangerous, and areas on Washington are considered to be the top five most dangerous. He stated that measures need to take place on County roads and commissioners are on board, but they need support from the towns. He stated that we need to get past moving trucks and cars more efficiently and make roads more accessible as people want to walk, bike, and roll.

Jacqueline Romney, resident, stated that there are many issues going on with Cooper's Pond. She asked if the borough would consider perhaps adding a dog park near Cooper's Pond, as Cooper's Pond has two signs that do not allow cars or dogs at Cooper's Pond. She stated if people will continue to bring dogs to Cooper's Pond, the borough should consider having another dog run near the park. She further stated that she has sent several emails regarding E. Church Street and would like to know if there will be an additional Do Not Enter sign on the street. She also asked if the parks can be kept dog free.

Mr. Gallo stated the signage will be added when the road is repaved.

John Smith, resident, stated he disagrees with having bicycle lanes. He stated that bicyclists do not use the bike lanes and are the main cause of accidents. He further stated that he has complained about this in the past, but kids ride the entire length of Washington Avenue and feel they have the right of way. He has suggested to the Police Chief to impound the bikes for those bicyclists who get in front of motorists and break the law. Mr. Smith stated there is a reason why there isn't a dog run at Cooper's Pond. He commented that parents bring their children to walk and fish at Cooper's Pond. If children see a dog, they want to pet it, and it becomes a dangerous situation. Mr. Smith stated that no dogs should be allowed in the park.

Mary Sullivan, resident, stated she is in agreement with Mr. Smith about not having a dog run at Cooper's Pond. She further stated that there is no place for bike lanes on Washington Avenue as it will create more accidents. Mrs. Sullivan questioned whether the newsletter continues to be delivered to residents' homes.

Mr. Gallo stated the newsletter is delivered to homes, but it has been slow this month because of bulk pick up. The newsletters are being placed in stores as well.

Barry Doll, resident, requested that residents stop putting memorials at Cooper's Pond. He commented that people are putting flowers and other decorative items on memorials. He requested the borough receive input and keep the museum informed with regards to renovations as some areas are historical.

There being no one else who wishes to be heard, Mayor Amatorio closed Verbal Communications II.

COUNCIL COMMENTS

The council members thanked all for coming to the meeting.

Mayor Amatorio thanked all for coming. He stated the Mayors Wellness Campaign was launched last Sunday. The public is invited to partake in the many events planned Monday through Friday. The schedule of all events is posted on the borough website. He invites the public to take advantage of the great activities that are being offered.
