

**OFFICIAL MINUTES OF THE
BOROUGH OF BERGENFIELD
MAYOR & COUNCIL REORGANIZATION MEETING
JANUARY 2, 2025**

At 7:00 p.m. Mayor Amatorio read the Open Public Meetings Act Statement: “In compliance with the Open Public Meetings Act, the notice requirements have been satisfied. SWEARING-IN OF COUNCILMEMBERS

Bergen County Clerk John Hogan stated he is pleased to report that democracy is alive and well here in Bergen County. Mr. Hogan stated that on Election Day on November 4, 2024, there were 684,900 registered voters in Bergen County. 463,837 cast their ballots in the Presidential Election by mail, in-person, and early voting. It was just shy of a 70% turn out. There was a 67.2% turn out in Bergenfield and excellent choices were made.

Bergen County Clerk John Hogan read the Election Certificate of Councilman-Elect Thomas A. Lodato. Councilman-Elect Thomas A. Lodato received 7,873 votes.

Bergen County Clerk John Hogan read the Election Certificate Councilman-Elect Hernando Rivera. Councilman-Elect Hernando Rivera received 7,696 votes.

PRESENTATIONS

He expressed that its a great family town because of the people who run it, putting time and energy to ensure residents of the borough have everything. Towns don't operate well by mistake. Bergenfield is a shining example of positivity when people work well together to get things done. He wished all a happy and healthy New Year.

Commissioner Marte congratulated Councilperson Lodato and Councilperson Rivera on their re-election. He thanked them for doing a great job in moving Bergenfield forward and for their hard work. Commissioner Marte presented Councilperson Lodato and Councilperson Rivera with a Certificate of Commendations on behalf of the Board of Commissioners.

STATEMENTS AND INTRODUCTIONS BY MEMBERS OF THE GOVERNING BODY

Councilperson Lodato wished all a Happy New Year and thanked all for coming to bear witness to this event. He also thanked MaryAnne and Christina for administering the oath of office, which is the 7th time they do so. He starts today his 19th year of serving as councilman. During the past 18 years, he's had the pleasure of working with four borough administrators, five Mayors, six police chiefs, sixteen fellow council members, as well as numerous Chief officers and line officers of the fire department, many borough employees, and countless volunteers who served the various boards and committees which make this borough function. Each of those individuals have always given 100% of their time and energy to assist the residents of this borough in any way they can. The Mayor, Council, and Borough Administrator have an excellent working relationship and continually address the routine day to day problems as well as challenges that arise with no advance notice. The Mayor and council members have mutual respect for each other and have the best interest of the residents at heart. They don't always agree on every issue, but difficult decisions are made after full discussion, deliberation, debate, and expression of independent thought. As you can see by those in attendance tonight, we also have a good relationship with those that govern at the State and County levels and do assist the borough many times. He looks forward to working in the next few years to move the borough forward and to continue to make this town the best community to reside in and raise a family.

Councilperson Rivera thanked God for allowing them to be here tonight and see another new year. He thanked Senator Lagana, Commissioner Marte, Bergen County Clerk Hogan, Police Chief Rabboh, the fire department, and the citizens for being present. He thanked all for providing support and expressed his deepest gratitude to his wife Lena, his children, his granddaughter Isabella and friends. He stated without their support, he would not be standing here. He congratulated Councilperson Lodato and his family for his re-election. This is his twelfth year and many of his ideas have become reality in the daily lives of community, including the 10-year road plan, upgrading the parks, and construction of professional soccer and football fields. They provided vaccines, testing, and food to residents during COVID. Councilperson Rivera stated 7 years ago, he envisioned constructing a new borough building that is now on the brink of having a ribbon cutting ceremony for it by Memorial Day. The Mayor and Council, along with Bergen County officials, state legislators and the Borough Administrator Corey Gallo, are an incredible team. He is confident they will continue building meaningful projects, including a community center in the next three years leaving a legacy for future generations. He wished all a prosperous, happy, and healthy New Year.

Councilperson Deauna stated that 2024 was a remarkable, productive year. There were challenges, but with the Mayor's leadership, they were able to achieve the projects Bergenfield residents are proud to see. He acknowledged Borough Administrator Gallo for being instrumental in building the new Borough Hall. There is a lot on their plates this year.

There is nothing that can stop them from moving forward for the betterment of Bergenfield. He welcomed all distinguished guests present.

Councilperson Almonte congratulated Councilperson Rivera and Councilperson Lodato for their dedication and service to Bergenfield. He knows their legacy will continue to inspire the residents of Bergenfield.

Councilperson Kornbluth wished all a happy New Year. She thanked Senator Lagana, Commissioner Marte, Councilman Ezio Altamura for being present and joining the celebration. She congratulated her colleagues and friends on their re-elections. Councilperson Kornbluth stated she looks forward to serving on the council with them for many more years and celebrating many more birthdays together.

Councilperson Pascual congratulated Councilperson Lodato and Councilperson Rivera. They've been through a lot since he's been on the council. They are able to do a lot for the community together for the future. It starts with infrastructure, the new building that's going to stand for another 100 years, roads paved, and parks created to keep the kids off the streets. There is a lot of back and forth with agreeing to disagree. They have a vision for Bergenfield and it's still not 100%, but it's getting there. They are here for the residents and future leaders of the town. He thanked for all the council's support and hopes for a prosperous New Year.

Mayor Amatorio congratulated Councilperson Lodato and Councilperson Rivera. He thanked Commissioner Marte, Father Oliver, Police Chief Rabboh, Fire Chief Zadrozna, Senator Lagana, Bergen County Clerk Hogan, Councilperson Altamura, and the council member's families for being present. This is his sixth reorganization meeting and remembers focusing on key priorities, including upgrading infrastructure, economic development, financial stabilization, and investment in recreational facilities for the youth. He stated today they have accomplished those goals and have done what's best for the community. They will be putting together a committee shortly to study and discuss a recreation center. Bergenfield is growing and moving forward. Memorial Park will be improved with additional parking spots and statues for veterans and heroes of the nation. He thanked the council and residents of Bergenfield for their support.
