ORDINANCE 17-2519- AN ORDINANCE AMENDING CHAPTER 344 OF THE CODE OF THE BOROUGH OF BERGENFIELD, ENTITLED "SANITARY CODE"

was introduced at a regular meeting of the Mayor and Council of the Borough of Bergenfield, in the County of Bergen, New Jersey, held on Thursday, November 9, 2017 and will be further considered for final passage after public hearing at a meeting of the Mayor and Council to be held in the Executive Chambers, Bergenfield Municipal Center, 198 North Washington Avenue, Bergenfield, New Jersey on Tuesday, December 5, 2017 at 8:00 p.m. prevailing time, or as soon thereafter as the matter can be heard.

A clear and concise statement is to amend 344-47 entitled Dog Control to allow dogs in Veterans Memorial Park between dawn to dusk to access the dog park as set forth in the ordinance.

**AN ORDINANCE AMENDING CHAPTER 344 OF THE CODE OF THE BOROUGH OF BERGENFIELD,
ENTITLED "SANITARY CODE"**

WHEREAS, Chapter 344 of the Code of the Borough of Bergenfield sets forth all regulations regarding Sanitary Code within the Borough of Bergenfield; and,

BE IT ORDAINED, by the Mayor and Council of the Borough of Bergenfield, County of Bergen and State of New Jersey that those portions of the aforesaid set forth below are hereby amended as follows and that those portions of the Ordinance not set forth below shall remain unchanged.

Article VII: Animal Control
Section 344-47 entitled Dog Control.

A..Running at large. No person owning, harboring, or in charge of any dog shall allow it to run at large upon the public streets, in any public park, in any public building, and/or on any private property within the Borough without the consent of the owner with the exception of Veterans Memorial Park wherein owners with their dogs may enter between dawn and dusk to access the dog park with their dog leashed at all times while outside the perimeter of the park and until entry into the dog park.

Severability All provisions of this Ordinance are severable. If for any reason, any provision of this Ordinance is held to be invalid, the validity of the remainder of the Ordinance shall not be affected.

Effective Date. This Ordinance shall become effective upon final approval and publication, pursuant to law, and upon completion of all outstanding cases.
